(I) General Conditions: -

- 1.1 The tenderer shall submit Rs.1000/- (Rs. One Thousand only) for tender in the shape of Bank draft or BA-16 in favour of Addl.SE./ C.W Divn., PSTCL, Jalandhar Payable at Jalandhar towards the cost of tender documents/ specification which is non-refundable.
- 1.2 Tender of such bidders who do not enclose the demand draft/B.A-16 of cost of tender document/ specifications shall not be opened.
- 1.3 All tenders must be accompanied by earnest money at the rates and in the form prescribed in the tender document, except in the case of those tenderers who have specially exempted there under.
- 1.4 Conditional tenders will not be accepted. Tenderer will have to comply with all the rules and regulations under factory act, Industrial disputes act, E.P.F Act., Labour Laws and Bonus Act & Retrenchment compensation etc.
