Sealed tenders shall be received & opened on due dates given above. If the date of opening of tenders happens to be a holiday, tenders shall be opened on next working day at the same time & place. Tenders of the firms which do not purchase the tender documents in advance shall not be opened.

All tenders must be accompanied by earnest money at the rates prescribed in the tender documents except in the case of those tenderers who are specifically exempted there under. Earnest money deposited against other tenders will not be considered for this tender.

Firms having permanent earnest money deposited with PSTCL for TS Organization shall submit certificate to this effect from AO/CPC, PSTCL, which should be valid for three months immediately preceding the due date for tender opening. The amount of Permanent Earnest money deposit (PEMD) is Rs. Ten Lac & the same should have been deposited exclusively for TS Organization.

Conditional & Telegraphic quotations shall not be accepted. Price bids of those firms will not be opened who are blacklisted/debarred and the firms who are defaulters for 25% or more quantity for more than 9 months or any quantity for more than 15 months in making supplies against earlier purchase orders placed on them at the original last date & time of downloading of specification/documents from PSTCL website.
