- Earnest money shall be 2% of tender value with minimum of Rs.5000/- whichever is higher.** Earnest money shall be nil for work order below Rs.50,000/- as per Works Regulations The tenders from the firm having permanent earnest money for Transmission works shall also be accepted providing a certificate to this regard is contained in the envelope containing earnest money.
- The quoted rate should be valid for 120 days from the date of opening of tender.
- Tenders for part work, Conditional tenders, and telegraphic tender through telex, fax or tenders not on prescribed forms of tenders without earnest money in the required shape shall not be accepted.
- All the T&P/machinery required to carry out the work is to be arranged by the bidder.
- In case the date of opening of tenders happens to be a holiday, the tenders will be received and opened on the next working day at the same time.
