Sub: Checking/Verification of details of outward supplies of taxable goods and/or services uploaded by Registered taxable suppliers in GSTR-1 on GSTN portal.

As per prevailing practice this office is making payments on behalf of purchases made by different Purchasing Agencies in PSTCL on the basis of payment release order issued by Purchasing Agencies .

Now with the implementation of GST details of outward supplies of taxable goods and/or services will be uploaded by the registered taxable suppliers in GSTR-1 on the GSTN portal up to 10<sup>th</sup> of the following month which has to be checked/ verified by the PSTCL. The field offices are accountable for the verification of data furnished by supplier in GSTR-I. However, for Procurement at central level the responsibility of verification of data lies with the Procurement Offices. AO/CPC will be providing a monthly information regarding payment details to the procurement agencies by 1<sup>st</sup> working day of succeeding month so that they can upload by due date the accurate invoice particulars of supplier with details in the GSTR-2 through software developed by IT section of PSTCL.
