- c) Firm should be registered or should have past experience of similar work with PSTCL/PSPCL or other state/center department.
- 2. If the quotations are not received in this office on time, then it will not be accepted.
- 3. The undersigned can increase/decrease the quantity of order as per actual site requirements or cancel the tender/quotations at anytime without any notice.
- No subletting of work shall be permitted at any stage.
- 5. Quoted rates shall include everything and nothing extra over & above the quoted rate shall be payable, GST (if applicable) shall be paid as per actual.
- 6. The quoted rates shall remain valid for 30 days from the date of opening of bid.
- 7. Hundred percent (100%) payment of the contract shall be paid after completion of work to the entire satisfaction of the office in charge.
- 8. Statutory taxes, if applicable should be paid after allowing abetments /discounts/exemptions permissible under the relevant act so as to ensure that there is a least payment for PSTCL under the provision of law.

#### 12. PAYMENTS & DEDUCTIONS:

The bills for payment should be submitted in duplicate in the office of Sr. Executive Engineer, P&M Division, PSTCL, Ropar.

- (a) Income tax and any other taxes shall be deducted as per norms of GOP/GOI, if applicable.
- (b) Labour cess @ 1% shall be deducted, if applicable
- (c) EMD of successful bidder shall be released after the certification of successful completion of work. EMD of unsuccessful bidders shall be refunded after work allotment.

#### 13. TIME SCHEDULE:

Completion period is thirty days from issue of this work order.

Contractor has to mobilize adequate resources to meet his commitments to PSTCL as indicated from time to time. In case due to reasons not attributable to the contractor, the work gets delayed and additional manpower/resources have to be mobilized so as to expedite the work to meet various milestones, same shall be done within the quoted rates as per Rate Schedule, at no extra cost to PSTCL.

#### 14. Penalty for delay in work completion:

Penalty for delay in order completion will be deducted as per PSTCL's work regulations (erstwhile PSEB) amended up to date.

#### 15. Jurisdiction:

The filling of any suit in case of any dispute shall be within the jurisdiction of the Courts at Ropar. The Sr. Executive Engineer, P&M Division, PSTCL, Ropar. in charge of work shall defend, initiate as required, the cases including arbitration case on behalf of the Owner.
