6. The EMD deposited by unsuccessful bidders will be returned after allotment of purchase order to the successful bidder within one month. Under any circumstances, PSTCL will not be liable to pay any interest

7. EMD shall be forfeited in case of withdrawal modification of an offer

within the validity period.

8. The EMD/ Security submitted is liable to be forfeited, if the contractor fails to provide material as per terms and conditions of the contract/ purchase order.

9. All the rates should be quoted by contractor in ink writing without

any overwriting/ cutting.

10. Jurisdiction of Civil Court shall at Samana (Patiala)

11. Contractor shall be fully responsible for his material deployed by him for fulfilling the purpose of this tender and any damage to the purchased material shall be recovered from him.
