(B-1) Terms and Conditions for Vehicles:

- The vehicle will be used as conveyance by PSTCL and will be stationed at 400 KV Sub Station Sri Muktsar Sahib for utilisation at our offices Punjab, Chandigarh, Delhi and also for deputing to the neighbouring states of Haryana, Himachal Pradesh, Rajasthan and J&K.
