- 7. Rates quoted in tender should be valid for 120 days.

- 8. Those bidders who are issued tender, specification are to submit their complete tender documents on or before the last date mentioned above along with fixed earnest money Rs (As per tender documents). For more details on earnest money, tender documents may be referred.
- 9. Not with standing anything stated above, the competent authority reserved the right to assess the bidder's capabilities and capacity to execute the contract satisfactorily before deciding on issue of tender documents and even afterwards for deciding about awarding the work.
