1. The above prices are inclusive of WCT, Income Tax and any other State/Central Govt. Tax as applicable compliance of various provisions of EPF as principal employer shall be the sole responsibility of the contractor. However service tax and education cess there up on shall be paid extra, as per actual against documentary proof.
2. Any unforeseen foundation cropped during the execution of work shall be paid proportionate to the volume of the concrete of similar foundation.
3. Dismantlement of the tower /conductor shall be paid 50% of tower erection of stringing & sagging rates.
4. In case of erection if any foreseen tower/Structure required to be carried out during the execution of work shall be paid @ 7521/- per MT.
5. The work is to be completed within 1 month from the date of issue of detailed order.
6. Tenders shall be opened in the presence of the tenderers or their authorised representatives who wish to be present.
7. Specification of tender can be obtained from the office after paying tender specification fee of Rs. 500/- before 12.00 Noon on dated 25-2-16 and quotations are to be submitted upto 3.00 PM on the same day.

All tenders must be accompanied by earnest money in shape of Transco cash receipt or pay order, Demand draft in favour of Punjab State Transmission Corporation Limited, payable at Mohali in a separate envelope except in the case of those Venders who are specifically exempted for the same.

The tenders will be submitted in two parts i.e part 1 containing earnest money and part II containing price bid. Tenders without earnest money shall not be opened. Earnest money shall be 2% of tender value subject to minimum of Rs. 5000/- . The tenders from the firm having permanent earnest money for Transmission works shall also be accepted providing a certificate to this regard is contained in the envelope containing earnest money.

8. The quoted rate should be valid for 120 days from the date of opening of tender.

The required drawings can be seen on any working day in the office of the Addl. Superintending Engineer TLSC Divn. PSTCL Mohali .


10. Tenders for part work, Conditional tenders, telegraphic tender through telex, fax or Tenders not on prescribed forms or tenders without earnest money in the required shape shall not be accepted.
11. All the T&P/machinery required to carry out the work is to be arranged by the bidder.
12. Tenders for part work, conditional tenders shall not be accepted.
13. The competent authority reserves the right to increase/decrease the scope of work or also reject any or all the tenders so received without assigning any reason whatsoever.
14. Tenders received after the due date & time, even if posted before the due date of opening shall not be entertained at all.
15. All the material including Cement & Steel shall be provided free of cost from Punjab State Transmission Corporation Limited store at Ablowal (Patiala) or Jamsher. The transportation cost of the same to be borne by the contractor.
