S.E, C/W Divn., PSTCL, Mohali towards cost of tender documents/specification (non refundable). Tender of such bidders who do not purchase the set of NIT specifications, shall not be opened.
3. All tenders must be accompanied by earnest money at the rates and in the form prescribed in the tender document accepted in the case of those tenderers who have specially exempted there under.
4. Conditional tenders will not be accepted.
5. Tenderer will have to comply with all the rules and regulations under factory act, Industrial disputes act, E.P.F Act., Labour Laws and Bonus Act & Retrenchment compensation etc.
6. The tender shall be issued to those tenderers who have Vat. No.
7. Tender received telegraphically through telex or Fax/e-mail shall not be accepted.

8. The competent authority reserves the rights to reject any or all tenders without assigning any reasons.
