General Terms & Conditions:-

1. The Tender documents cost is not charged as per Financial Advisor, PSTCL, Patiala(Budget Section) O/o No: 10 dt: 22-2-18 and Earnest Money need to be paid in the form of cash or Demand Draft drawn on any scheduled bank in the favour of Senior executive engineer, P&M Civil Maintenance Division, PSTCL Jalandhar.
2. Earnest money shall be 2% of tender value with minimum of Rs.5000/- whichever is higher. Earnest money shall be nil for work order below Rs.50,000/- as per Works Regulations. The Earnest Money along with Documents should be kept in envelope duly sealed super-scribed "EARNEST MONEY" and Quotation should be kept in separate envelope duly sealed super-scribed "QUOTATION".
3. Quotations not accompanying the EMD as per sr. no. 2 will not be entertained.
4. Tenders for part work, Conditional tenders, telegraphic tender through fax or tenders not on prescribed forms of tenders without earnest money in the required shape shall not be accepted.
5. A set of tender documents (non-transferable) containing technical specifications, general instructions, terms & conditions can be downloaded from www.pstcl.org or obtained from the office of Sr. Xen P&M Divn, PSTCL Jalandhar by dated 02.02.2024 up to 01:00 PM

6. Work shall be carried out as per PWD specifications to meet with the requirements of the work at site to the entire satisfaction of the Engineer-in-Charge.
7. GST is applicable as per Govt. norms.
8. The quoted Rate shall be valid up to 120 days and shall remain firm through to the completion of work.
9. If the work is not completed within stipulated period, PSTCL shall impose 0.5% penalty per week subject to the maximum of 5% of the Total amount.
10. Income Tax, Labour cess shall be deducted at the source as per prevailing rules and rates.
11. Security deposit: 5% of the gross value of the work done will be deducted from the running bills as security deposit. No interest shall be payable to contractors on the amount of security deposit.
12. All statutory rules and regulations such as EPF regulations, Labour Rules and Regulations, wages regulations etc. shall be followed by the contractor. The contractor will be fully responsible for any kind of penalty levied by Central/ State Govt. or any other agency for not following the statutory rules and regulation.
13. The quotation should accompany PAN Proof, GST Registration proof, a valid registration of the firm with Pb. PWD, MES, PSPCL, and PSTCL etc. and Allotted EPF Code Number from Employees Provident Fund Commissioner and latest copy of challan of Deposit of EPF of the employees. Or L&C Societies with employee strength of less than 20 employees are exempted from EPF scheme. In such cases, they should submit an affidavit or EPF exemption certificate issued by the competent authority.
14. The Tenderer should possess the requisite documents before the date of publishing of this Tender.
15. Payment for the work done will be made by Sr. Xen civil Mtc. Division Jalandhar.
16. The undersigned reserves the right to cancel the aforesaid tender at any stage without assigning any reason.
17. In case the date of opening of tenders happens to be a holiday, the tenders will be received and opened on the next working day at the same time.
18. The competent authority reserves the right to increase/decrease the scope of work or also reject any or all the tenders so received without assigning any reason whatsoever.

Bidders should note that in case of award of contract they shall themselves be responsible for compliance of various provisions of EPF Act 1952 amended up to date as principal employer, GST which ever are applicable. All obligations arising on this account shall be sole responsibility of the contractor.
