

Corrigendum No. -2

Tender No. SLDC/121/2014: Tender Notice for: Design, Engineering, Supply, Erection, Testing, Commissioning and Integration of Remote Terminal Units (RTUs) for SCADA/ EMS system in PSTCL on Turnkey Basis.

The following amendments have been made in the Tender No SLDC/121/2014:-

1. The qualifying requirements shall be read as follows:-

3.0 Qualifying Requirements

Following qualifying requirements shall form part of technical specification which shall be considered for the purpose of technical evaluation and to decide eligibility for opening of price bids. In case the bidder not fulfilling the Minimum Pass/ Fail Requirements but submits the bid, it will be out rightly rejected. No claim whatsoever shall lie against PSTCL for such submissions. Bidders are required to check the qualifying requirements before submitting the bids. However, the Purchaser reserves the right to waive the minor deviations, which do not materially affect the capability of the bidder to perform the contract. Qualification of bidder will be based on meeting minimum pass/ fail criteria specified in Part-A. The bidders shall also be required to furnish the information specified in Part-B in their bid to assess the general capability/ capacity of the firm to execute the job.

Part- A:

3.1 Technical Experience:

The bidder whose RTUs (Make/ Model) have been approved by the NRPC, New Delhi as specified or new bidders who are not already approved by NRPC and shall have previous experience in similar scope of supply as specified in this specifications in at least one (1) power utilities/ entities in India or abroad and further meeting the followings requirements shall be eligible:-

3.1.1 Each of the above jobs should consist of at least **5 no. RTUs**.

3.1.2 RTUs of the above executed jobs should be in successful operation for at least 2 years.

3.1.3 The details of above to be submitted as per the format given in Annexure-XIV.

3.1.4 The bidders (RTU Make/ Model) who are not already approved by NRPC shall have to come for detailed testing of their offered RTU at PSTCL/ SLDC during the Technical Evaluation process of the Tender to show compliance of their offered RTU with respect of the present TE specification. For this they will be called for detailed testing by PSTCL/ SLDC after opening of the tender as soon as possible.”

Besides above Technical Experience, financial capabilities and Part-B consisting general requirements shall remain as such.

2. Clause No 4.1.3 (Page 9), GTP Annexure-XIII (Clause 1.1, 1.2 & 1.3-Page 97), Sr. No. 3 (Terms & Conditions at Page 5) and wherever NRPC pre-approval stipulations are mentioned in the TE shall be considered amended in line with the above amended qualifying requirements.

3. The quantity of Frequency Transducers in Annexure XX (A) shall be read as 118 nos. & spare quantity shall be read as 6 nos.
