- 2. Bidder whose work order has been cancelled in the past due to unsatisfactory work, are not eligible to apply.
- 3. The rates should be valid for 120 days from the date of opening of tenders.
- 4. Tenders received through telex/telegraphically or through fax shall not be accepted.
- 5. The undersigned reserved the right to cancel the quotation without mentioning any reason.
- 6. If the date of opening of tender happens to be holiday, quotations shall be received and opened at the same time of next working day.
- 7. Conditional tenders are liable to be rejected.
- 8. The quantity of work may be increased or decreased.
- 9. In case of work is not satisfactory a warning shall be issued. In case, if negligence still persists, the penalty will be charges at double of the rate on prorate basis.
- 10. The bidder is required to submit an Earnest Money Deposit (EMD) of 2% of the tender value in the shape of demand draft in favour of PUNJAB STATE TRANSMISSION CORPORATION (PSTCL) Payable at JAMSHER. Tender offered without EMD will not be accepted.
- 11. The Earnest money of successful bidder deposited with the quotation shall be converted in to security deposit after successful allotment of work order and shall be released after successful completion of contract (i.e after 1 year). Further, EMD shall be returned to unsuccessful bidder by this office after allocation of work order to ELIGIBLE bidder.
- 12. The personnel so supplied by the contractor shall be fully outsourced and they shall have no right to claim the regular services in lieu of outsourced duty performed by them.
- 13. The contractor will be responsible for any damage done to the building or other installation in the office complex.
- 14. The contractor should engage major (i.e age above 18 years) labour.
- 15. The contractor will engage labour which should be of good character and honest, hence he will be responsible for any theft on behalf of them.
- 16. Discipline and welfare of the workers shall be entirely responsibility of the contractor and indiscipline indisconduct on the part of deployed workers shall be promptly attend by the contractor & officer in charge is fully competent to direct the removal of such workers.
- 17. In case the contractor's employee suffers from any type of injury/death while performing duty in concerned office's complex/Yard, the contractor shall be wholly responsible to bear any claim of employee. The concerned office shall not be responsible at any level any type of claim and legal consequences.
- 18. If the condinator fails to carry out said work satisfactory his work order may be cancelled by undersigned at any time. This security and earnest money will stand forfeited.

- 24. GST and other taxes will be applicable as per statutory law.
- 25. All Legal proceedings against this contract shall be in the jurisdiction of Civil Court at Jalandhar.
- 26. If at any time any question, Dispute of difference, what so-ever arise between the vendor and PSTCL, upon or in relation to, or in connection with the order/contract, he may go for arbitration clause contained in Work Regulation 1997, as amended from time to time.
