Subject: - Deposit of Punjab State Development Tax (PSDT) for the period April

2018 to February 2019 before the close of FY 2018-19 (i.e. upto 31st March 2010)

It has come to notice that DDO wise registration was made by AO/Cash. All the DDOs have not deposited Punjab State Development Tax (PSDT) for the period April 2018 to February 2019 till date as per instructions issued from time to time by CFO organisation and latest vide memo no. 113-158/AOC/Tr. Gen. 124 dated 13.02.2019.

It is brought to your notice that as per the provisions of Section 19 of PSDT Act, if any registered employer (DDO) fails to deposit the amount of tax, a penalty equal to 50% of the tax can be imposed in addition to interest and penalty for continuation of offence.

It must be ensured that the amount of PSDT for the subject cited period should be deposited before 31st March 2019. DDO shall be held personally responsible if any liability occurs due to non-deposit, delayed deposit or non-submission of any information under PSDT Act.
