1. Sealed tenders are invited in duplicate for purchase of 176 no. Fuse with Assembly at various S/S under P&M Divn, PSTCL Patran.
2. Specification of required Material as under:-  
(a) Expulsion fuse element rating 50 Amp with fuse barrel & steel coil spring for 11KV Capacitor bank.

4. No Corporation employee or his family member/ relative can participate in the tendering process. In case of any violation, the contract shall liable to be cancelled and such employee shall be liable for Disciplinary action.

6. The contractor is required to submit an Earnest Money Deposit (EMD) of 2% of the Tendered value subject to minimum of Rs 10000/- in the shape of demand draft in favour of PSTCL. 10. All the rates should be quoted by contractor in ink writing without any overwriting/ cutting.

12. Contractor shall be fully responsible for his material deployed by him for fulfilling the purpose of this tender and any damage to the purchased material shall be recovered from him.
