Subject: CE/HIS&D Agenda no. 04/CE/HIS&D dated 13.02.18-Regarding Recovery of payment of Special Allowance made to the Officials authorized as Drivers.

The decision taken by Board of Directors in its 47th meeting held on 06.03.2018 at VIP Guest House, Mohali, on the above subject is as under:-

1. Special Allowance as admissible to Drivers be paid to the officials i.e. JE/AJE/SSA/LM/ALM/LDC from Sr. No. 1 to 27 (List attached) who had been authorized to perform the duties of Drivers w.e.f. the date of performing the duties as Drivers upto 26.07.2016 and not to recover the admissible allowances already paid to them by making applicable instructions issued vide erstwhile Secretary PSEB, Patiala memo No. 112960/113442/ENG-2(30)75 dated 22.03.2002, which were applicable only to the Operation Wing earlier.
2. Risk Allowance or any other allowance admissible to the officials on their original posts while performing the duties of drivers, if already paid, be recovered.
3. No LM/ALM/SSA shall be allowed to perform the duties of drivers beyond 30.04.2018.
