Finance Circular

Office Order No. 533 /PRC-307/2006/Loose Dated : 13 / 06 / 2012


Punjab State Electricity Board now PSPCL vide its Office Order No.488/PRC-307/2006 dated 08.04.2010 (FC No.16/2010) has made Second amendment - 2010 in the Punjab State Electricity Board (Revised Pay). Regulations, 2009 w.e.f. 01.01.2006 with the following conditions: -

"NOTE : If the Punjab Govt. issues any clarification with regard to the above at a later stage then the above amendment shall be reviewed/implemented accordingly and excess payment, if any, will be recoverable. Undertaking in this regard be also obtained."

Thereafter, Govt. of Punjab, Finance Deptt. (Finance Expenditure-IV Branch) vide No.2/6/7-2FE4/318 dated 03.05.2010 addressed to Deptt of Irrigation & Power, Chandigarh, copy of which was endorsed by his office vide Endst.No.11/88/ 2009-872/1556 dated 26.05.2010 in which it was observed that the clarification issued vide FC NO.16/2010 (O/O No.488/PRC-307/2006) dated 08.04.2010 is not consistent with the provisions of Rule-3(b) read with Rule-5 of Punjab Civil Services (Revised Pay) Rules, 2009. According to the provisions of these Rules a Govt. employee can switch over to the revised pay structure from the date of first promotion or first upgradation only and advised to ensure that this clarification is not implemented.

Keeping in view the above instructions of Punjab Govt., the following orders/clarifications are issued: -

- (1) Punjab State Electricity Board (Revised Pay). Regulations, 2009 (Second Amendment-2010) issued vide Finance Circular No.16/2010 (O/O No.488/PRC-307/2006) dated 08.04.2010 is hereby withdrawn.
- (2) According to the provisions of Punjab State Electricity Board (Revised Pay). Regulations, 2009 - Regulation 3(b) read with Regulation 5, a Board employee can switch over to the revised pay structure from the date of first promotion or first up-gradation.
- (3) Due to this, employees who have already exercised option w.r.t. F.C.No.16/2010 (O/O No.488/PRC-307/2006) dated 08.04.2010 must exercise revised option within one month from the date of issue of these orders failing which option would be assumed under Regulation 3(b) of F.C.No.15/2009(O/O No.478/PRC-302/2006) dated 15.10.2009.
