6. Requests for issue of tender documents received late due to any reason including postal delays or request not carrying information / documents asked vide Para 3 or request received through telex, fax, telegraphically shall be rejected. Conditional requests are also liable to be rejected.
7. Rates quoted in tender should be valid for 120 days.
8. Those bidders who are issued tender, specification are to submit their complete tender documents on or before the last date mentioned above along with fixed earnest money Rs (As per tender documents) . For more details on earnest money, tender documents may be referred.

18. Bid Capacity:

The available Bid capacity at the expected of bidding (to be calculated on the basis of prescribed format vide Annexure 1&2) of the prospective applicant shall not be less than the estimated amount put to tender of intended job.

The bid capacity of the prospective bidders will be calculated as under:  
Assesses Available Bid Capacity=  $(A \times N \times 2 - B)$

Where

A= Maximum value of civil engineering works executed in any one year during the last five years taking into account the completed as well as works in progress.

B= Value of existing commitments and on-going works to be completed during the period of completion of the projects for which these bids are being invited.

N=The time period which varies from work to work, however most of works of WRD do fall in category N=0.5 (Value considered as per SBD for world bank projects)

The general formula is as detailed below:-

If, completion period <6 months, N=0.5 Therefore,  
Bid capacity=  $A \times 0.5 \times 2 - B = A - B$

If, completion period <12 months, N=1 Therefore,  
Bid capacity=  $A \times 1 \times 2 - B = A - B$

If, completion period <18 months, N=1.5 Therefore,  
Bid capacity=  $A \times 1.5 \times 2 - B = A - B$

Bid capacity=  $A \cdot 0.5 \cdot 2 \cdot B = A \cdot B$

If, completion period \_ <12 months, N=1 Therefore,  
Bid capacity=  $A \cdot 1 \cdot 2 \cdot B = A \cdot B$

If, completion period \_ <18 months, N=1.5 Therefore,  
Bid capacity=  $A \cdot 1.5 \cdot 2 \cdot B = A \cdot B$

If, completion period \_ <24 months, N=2.0 Therefore,  
Bid capacity=  $A \cdot 2 \cdot 2 \cdot B = A \cdot B$
