## (A) General Conditions

- 1. The following documents are to be provided along with the tender/quotation:
  - a) Registration copy of the vehicle.
  - b) Route permit.
  - c) Receipt of Tax/LCV Tax certificate.
  - d) Copy of Insurance.
  - e) Copy of driving license of driver.
  - f) Copy of valid pollution certificate
  - g) Pan card of Prop:
  - h) Aadhaar Card of Prop:

In case the contractor is willing to provide **new vehicle**, then he should be considered only after qualifying the terms & Conditions of the Specification subjected to submission of all documents as listed above within Two weeks from the date of issue of Intimation letter from this office to him.

- 2. Firm should have GST number.
- 3. Tender offers without EMD will not be accepted.
- 4. The EMD deposited by unsuccessful bidders will be returned after allotment of work to the successful bidder within one month. Under any circumstances, PSTCL will not be liable to pay any interest on the EMD.
- 5. The EMD/Security submitted is liable to be forfeited, if the contractor fails to provide services as per terms and conditions of the contract/work order.
- 6. In case of withdrawal of vehicle from service of PSTCL, the contractor shall have to inform to PSTCL, 30 days in advance otherwise 30 days payment shall be deducted from their bill/security as penalty. However, the vehicle can be disengaged by PSTCL by serving 15 days notice in advance to the contractor.
- 7. The contract shall be initially for a period of one year, which may be extended on mutual consent on year to year basis, for further three years, subject to the performance of the Vehicle/ Service Provider/subject to condition that the vehicle can continue in the department upto 7 years of its life. Hence the maximum period for which a vehicle can be hired is 4 years, After a period of 4 Years, a new tender needs to be floated. Market rates and the Life/kms of the vehicle as specified in the PSTCL's latest Transport Policy.
- 8. The undersigned reserves the right to reject any or all the tenders so received without assigning any reason.
- 9. Tender received through email/telegraphically/fax/conditional tenders/without earnest money shall not be accepted.
- 10. All matters relating to transportation, traffic police and local administration will be dealt by the Contractor himself at his own cost.
- 11. The bidder has to quote the rates on the "Schedule of Prices" as per tender documents to be received from this office.
- 12. The Contractor is required to receive tender documents free of cost from O/o Addl.SE, Protection Divn., PSTCL, Mohali. Tender of only those firms shall be accepted who have received tender documents from this office upto 21/02/24 (16:00 hrs) on any working day. No requests through e-mail for receiving tender documents shall be entertained.
- 13. If the quotations are not received in this office on time then it will not be accepted.
- 14. In case any holiday/any other guidelines issued by Election Commission declared by Govt./ Other natural hazards, the tender will be opened on the next working day.
- 15. All the rates should be quoted by contractor himself or his representative with ink writing.
- 16. The quoted rates should be valid for 120 days.
- 17. The tenders shall be accepted up to 23/02/24 (11:00 hrs) and shall be opened on the same day i.e. 23/02/24 (12:30 hrs) in the presence of contractors/bidders, who may choose to be present in the office of Addl.SE/Protection Divn., PSTCL, Mohali.
