Following Terms and Conditions will be applicable on them for attending the above Program:-

- During the above period they will be considered on duty for the purpose of pay and other allowances.
- 2) They will be entitled to claim TA/DA as per PSPCL TA Regulation-1972 (as amended from time to time). The expenses so incurred will be charged to account head 76.181 of concerend DDO reimbursing the TA Bill. Reimbursment of TA/DA will only be done after submission of training report. Their TA claim shall be allowed by their Controlling Authority/Account Section only after they certify (along with No. and Date) that requisite report has been submitted to ASE/Training Cell, PSTCL, Patiala.
- The minimum training cost is Rs.2,10,675/- (Rs. Two lakh ten thousand six hundred and seventy five only) inclusive of service tax for a batch of minimum 25 participants including boarding & lodging. The payment shall be released by AO/ Cash, PSTCL, Patiala and shall be chargeable to account head 76.151
- 4) Payment shall be made through Cheque/ Demand Draft in favour of "Director General, MGSIPAP" payable at Chandigarh. DD/RTGS charges shall also be borne by PSTCL
- Participant will ensure daily attendance on the attendance sheet at the training center, failing which charges of the prog. will be recovered from them.
- 6) Participant will submit report and Training Kit of the programme in the office of ASE/Training Cell, PSTCL, Patiala. Their TA claim shall be allowed by their controlling authority/ Account Section only after they certify (along with no. and date) that requisite report has been submitted to ASE/Training cell, PSTCL, Patiala.
- In case participants do not attend training programme as per schedule, charges
  of the programme will be recovered from them.
- 8) They will not be provided any joining time except the time required for joining the programme.
- The institute shall supply following documents:
  - a) Invoice (mention clearly service tax or any other tax in the Invoice)
  - original attendance sheet verified by the training institute.

10) In case any participant requires changing his or her name due to unforeseen circumstances, he/ she is required to send their request through his concerned Chief Engineer with recommendation of two names of Officials of same designation.
