In exercise of the powers conferred by sub-section(6) of Section 42 of the Electricity Act,2003 read with Punjab State Electricity Regulatory Commission (Forum and Ombudsman) Regulations, 2016 amended from time to time, the Punjab State Electricity Regulatory Commission is pleased to appoint Er. Gurinderjit Singh as Ombudsman, Electricity, Punjab on the following terms and conditions:-

1. The appointment shall be for a period of three years from the date of his taking the charge which may be extended by the Commission upto a maximum period of five years subject to age limit of 70 years.
2. He will be paid a fixed remuneration of Rs. 1,00,000/- (one lac) per month and Rs.10,000/- (ten thousand) per month towards Transport Allowance as prescribed by the Commission.
3. His office shall be located at 66 KV Grid Sub-Station, Plot no. A-2, Industrial Area, Phase-I, S.A.S Nagar(Mohali).
4. Before assuming charge, he will subscribe to the oath of office and secrecy before Chairperson, PSERC.
5. He may relinquish his office by giving a notice of not less than 03 months in writing to the Commission.
6. The other terms and conditions of his appointment shall be as specified in the Punjab State Electricity Regulatory Commission (Forum and Ombudsman) Regulations,2016 as amended from time to time.
