### TENDER DOCUMENTS / SPECIFICATION FOR TENDER ENQUIRY NO.- 01/2023-24

The following instructions must be carefully observed by all the tenderers. Quotations/Tenders not strictly in accordance with these instructions will be liable to be rejected.

- The tender shall be submitted in three parts i.e. Part-I, Part-II & Part-III. The document(s) of each part shall be submitted in a separate small envelope & all the three small envelopes shall further be submitted in a large envelope. This sealed large envelope shall be super scribed with "Tender for hiring of Vehicle" clearly on top of the envelope, addressed to Sr Xen/Protection Division, PSTCL, Gurdaspur and must reach this office up to 11:00 AM on 29.01.2024.
- 2) The following procedure will be adopted for the opening of the Tenders:

### A. PART-I - EARNEST MONEY:

The first part will consist of Earnest Money Deposit (EMD) of 2% of the total tender value (inclusive of GST) rounded off to a multiple of Rs.10 on higher side, or minimum Rs.5000/- whichever is higher through Net Banking or RTGS/NEFT from the Concerned Tenderers.

The envelope Part-1 - 'Earnest Money 'shall be submitted in a separate envelope on which the **''Earnest money against NIT/Tender Notice No. 01/2023-24 due for opening on 29.01.2024** shall be clearly written. In case earnest money is not received along with tender, Part-II & Part-III will not be considered.

#### **B. PART-II - BIDDER INFORMATION/PROFILE:**

The envelope marked Part-II - 'Bidder Information/Profile' would consist of Bidder Information/Profile to be provided on the duly filled Performa Annexure-'A'. Following documents of the vehicle provided for hiring shall be provided alongwith Part-II - 'Bidder Information/Profile' i.e.

- i. Commercial Registration Certificate of Vehicle.
- ii. Insurance cover renewed upto date.
- iii. Valid Pollution Certificate.
- iv. Copy of Pan Card.
- v. Copy of valid Permit.

- vi. Copy of valid Driver's Licence and Adhaar Card of the Driver.
- vii. An Undertaking in the form of affidavit by contractor / service provider for submission of vehicle documents shall be acceptable in case of new vehicle is being purchased by contractor / service provider.

## C. PART-III - PRICE BID:

The envelope marked **Part-Ill - 'Price Bid'** would consist of rate quoted for each item under Schedule B of Annexure 'B' for hiring of vehicle on monthly basis.

- 3) The EMD/Security submitted is liable to be forfeited on the following grounds:
  - i. On revocation of tender and/or change in the same without consent of PSTCL.
  - ii. On non-completion of work.
- 4) The Work order for outsourced vehicle, for vehicle not more than 5 years old, shall be extendable on year to year basis, for a further period of three years, subject to the performance of the Vehicle/Service Provider. Hence the maximum period for which a vehicle can be hired is 4 years. After a period of 4 years, a new tender needs to be floated.
- 5) Only commercial Vehicle with entry in Registration Certificate should be hired. No corporation official/employee or his family member/relative can participate in the tendering process. In case of any violation, the contract shall be cancelled and such official/employee shall be liable for disciplinary action. If the contractor does not supply yellow number plate vehicle then his security will be forfeited and he will be black listed.
- 6) All matters relating to any halt charges, penalty including challan, damages, court case, police case, transportation, traffic police and local administration will be dealt by the contractor himself at his own cost.
- 7) The undersigned on behalf of PSTCL reserves the right to reject any or all the tenders so received without assigning any reason. PSTCL will not be responsible for and will not pay for expenses or losses that may be incurred by the tenderer in preparation of tender.
- 8) Any conditions that may be imposed by transport policy of PSTCL (along with changes from time to time) shall be applicable and supersede the conditions mentioned herein or elsewhere in this document.
- 9) The tenderer should quote rate of all items. The tender must be complete in all respects.
- 10) No overwriting should be made in the quotation. Any cutting must be attested by full signature.
- 11) The rates must be quoted on letter pad of the firm. Tender documents once submitted shall not be returned.
- 12) The officer inviting tenders or an officer deputed by him, may extend the due date for submission of tenders in case of poor response defined by receipt of less than three quotations up to the fixed time or under any unforeseen situation, incomplete, without the required amount of EMD or not properly sealed tenders and tenders received telegraphically/ through fax/ late due to any reason whatsoever will be rejected. Tenders shall be signed by the owner or person holding power of attorney by him to do so.

# A) <u>TERMS AND CONDITIONS FOR HIRING OF VEHICLE:</u>

The contractor will depute Scorpio/Xylo/Mahindra Bolero/TUV 300 or equivalent in price, vehicle not more than 5 years old (from the date of NIT) for period of 1 year for Protection Division, PSTCL, Gurdaspur.

- 1. Outstation night halting charges (10:00 pm to 06:00am) @ Rs. 300/- shall be paid extra by PSTCL.
- 2. Vehicle shall possess a valid Permit. No liability for the Interstate Permit charges would be borne by the PSTCL.
- 3. The vehicle shall be available for use round the clock, for utilization at our offices in the State of Punjab, Chandigarh, Delhi and also for deputing to the neighbouring States of Himachal Pradesh, J&K, Haryana and Rajasthan.
- 4. Toll Tax/Parking charges etc. whenever paid shall be reimbursed by the PSTCL as per actual, subject to the production of its receipts.
- 5. The cost of consumables, in addition to Diesel, Mobile Oil, Lubricants, tyres,tools,coolant etc. will be borne by the contractor.

- 6. Maximum 4 days off in a month shall be allowed including for service/ repair and upkeep of vehicle without any deduction of payment provided vehicle has been regularly in use prior to the service. This would be permitted on prior intimation and consent from the concerned officer. Service shall be planned on Saturday/Sunday or public holidays. In case of non availability of vehicle breakdown/servcing or any working day, alternate vehicle shall be provided.
- 7. The kilometer run, from the point of departure of vehicle for maintenance/repairs and rejoin the duties, shall not be considered for billing.
- 8. In case of non-deputing of vehicle on receipt of requisition from the requisitioning officer or delay in sending the vehicle, a penalty of Rs. 1000/- per default per day shall be leviable.
- 9. The vehicle shall report to Sr Xen/Protection Division,PSTCL, Gurdaspur and shall move as per his/her instructions.
- 10. The vehicle shall be required at any hour of the day and the contractor shall be liable to provide the same.
- 11. The vehicle shall be provided with proper and adequate tools, spares, spare tyre and consumable in order to attend minor repairs while travelling.
- 12. Service provider/contractor shall ensure that sufficient diesel/fuel is available in the vehicle to enable urgent outstation journey. Also the service provider/contractor shall be intimated about fuel requirements and he shall ensure the same without any delay.
- 13. Service provider should also have valid pollution certificate for the vehicle and valid driving licence for driver and the same should be available with the driver and will be produced on demand.
- 14. Service provider shall obtain the passing/fitness certificate and update Registration of vehicle from the concerned registering authority at his own cost.
- 15. In case of accident, any type of challan, halt charges, penalty, damages, court case, police case etc. the sole responsibility will be of the Service provider/contractor of the vehicle and PSTCL will not be party in such cases.
- 16. The seats shall be well cushioned and should have fine, neat and clean seat covers and vehicle shall also have rubber floor mats.
- 17. Log Book should be maintained by the service provider.
- 18. All the entries of each journey like Date, Place ('from' as well as 'to'). Time of departure & arrival. Initial/final Kilometres readings along with KMs run, Purpose (along with additional details required in case of transportation of store material), signatures of Official/Officer performing journey (along with his designation) etc. should invariably be made in the vehicle's log book.
- 19. The vehicles shall be insured comprehensively, including insurance for driver, passengers and third party, during the period of engagement with PSTCL. Insurance premium shall be borne by the contractor. Lodging and settlement of any insurance claim shall be the contractor's responsibility.
- 20. The road tax and all other related expenses shall be paid regularly and kept updated by the contractor.
- 21. The vehicle shall be parked at suitable place provided by the PSTCL. In case the contractor/drivers parks the vehicle at any other suitable place of their choice, then the mileage from that place to the place of duty will not be paid to the contractor.
- 22. Variation of 05 paisa for cars and 8 paisa for other vehicles, for every Rs. 1/- variation in Diesel cost taking the base rate of diesel mentioned on page no. 9 of CTP, shall be applicable on actual kilometers run, effective from the 1st day of the subsequent month.
- 23. Cost of vehicle's registration, insurance, service/repair, road tax, salary/emoluments, allowances of the driver or any other charges will be borne by the service provider. Only fixed amount and variable charges for extra running kilometers, iff any, shall be paid by PSTCL.
- 24. The driver shall be punctual and polite and shall not be under the influence of any intoxicating drink or drug. The service provider shall be responsible for the conduct of the driver. In case of any complaint regarding the conduct of the driver, he shall be replaced immediately.
- 25. In case of lockdown or any other such type of situation, the rate of extra kilometers will be charged (recovered) for less killometers run from the monthly minimum kilometers.

26. In the future if the Indian Govt. imposes ban on diesel vehicle, in such situation, if the contractor provides the equivalent petrol vehicles at the same diesel rate and same terms & conditions as mentioned in the policy, then it shall be acceptable.

### B) TERMS AND CONDITIONS FOR THE DRIVER OF THE VEHICLE:

- 1. The contractor shall provide a driver along with the vehicle, who shall be properly dressed and well behaved, PSTCL reserve the right to direct the contractor to replace the driver of the vehicle, if he is not well behaved. If contractor will be unable to provide another driver, the PSTCL has the right to terminate the contract awarded to the contractor. The salary and other expenses of the driver including EPF, ESI etc shall be borne by the contractor.
- 2. The driver shall maintain a log book and the log book will be signed by the Officer/authorized official using the vehicle on the completion of journey. However, the log book will be verified from time to time by the Sr Xen/Protection Division, PSTCL, Gurdaspur or any other Authorized Officer of the PSTCL.
- 3. The contractor shall also make available the Registration Certificate of the vehicle with the driver of the vehicle along with all other relevant documents for insurance, Road Tax etc. necessary to keep the vehicle running on the road at all times during the contract period.
- 4. The driver of the vehicle shall hold valid license to drive in plain as well as on the hills and will keep the same at all times during duty hours. Validity of Driver's licence and fitness of driver should be ensured from time to time.
- 5. Service Provider shall ensure mobile facility to the driver at its own cost and local contact no. i.e phone no., mobile no. and address should be intimated to this office immediately before deputing him on the vehicle.
- 6. In case driver proceeds on leave or not available on medical grounds or any other ground, alternative replacement shall be the responsibility of service provider.
- 7. No lodging and boarding facilities will be provided to the driver of the vehicle by PSTCL.

# C. TERMS AND CONDITIONS FOR THE MONTHLY PAYMENT OF BILL OF THE VEHICLES:

- 1. Tax shall be deducted by the PSTCL as per income tax Rule/Act as applicable from time to time.
- 2. Security deposit equivalent to 5% of the contract amount shall be deducted from monthly bills. No interest will be payable on the amount of Security Deposit. Earnest Money Deposit (EMD) of unsuccessful bidders will be refunded within a period of 30 days from the date of issuance of work order.
- 3. TDS shall be payable by the service provider and service receiver as per instructions issued and applicable by the Govt. from time to time.
- 4. In the event of default on the part of the service provider/contractor in the faithful execution of contract, his security deposit shall be forfeited. The forfeiture of security deposit shall however be without prejudice to any other rights arising or accruing to the Corporation under relevant provisions of the contract like penalty/damages for delay in delivery including suspension of business dealings with Corporation for a specific period. It will, however, be refunded after the contract has been executed faithfully.
- 5. PSTCL reserves the right to terminate the contract of the vehicle without assigning any reasons, if the services or the condition of the vehicle is not satisfactory at any point of time during the contract period.
- 6. The concerned officer of the PSTCL shall make payment within 30 days from the date of submission of bill of previous month by the service provider.
- 7. The kilometer run for the journeys, which are not verified / signed by the concerned officer, shall not be payable.
- 8. A copy of Bank Pass book showing Bank Account number and IFSC is to be deposited in which payment of bill will be made vide NEFT/RTGS mode.

# D. PAYING AUTHORITY:

The paying authority will be the concerned Addl. S.E/P & M Division, PSTCL, Sarna.

### E. GENERAL CONDITIONS:

- 1. Rates will be inclusive of all taxes, duties etc. No other charges shall be paid extra.
- 2. GST shall be payable by the service provider and service receiver as per instructions issued and applicable by the Govt. from time to time.
- 3. All matter relating to transportation, traffic police and local administration will be dealt by the contractor himself at his own cost.
- 4. Total liability including third party, if any, in case of the accident of the vehicle or due to any kind of act of omission shall be of the Service Provider. PSTCL, directly or indirectly, shall not be responsible.
- 5. The bidder has to quote the rates on the "Schedule of Prices" enclosed as annexure-B along with terms and conditions duly signed on each page. Any deviation to the terms and conditions of NIT shall be specifically mentioned on schedule of prices sheet with signature of bidder and submitted along with the bid.
- 6. In case the date of issue/receipt of tender declared happens to be holiday, the tender will issued/received and opened on the next working day at same time.
- 7. Please do not forget to super scribe the envelope with the name of tender and due date of opening of tender.
- 8. Service provider/contractor will execute Contract Agreement on Non-judicial Stamp paper worth Rs. 25/within 10 days from the issue of this contract. A specimen of the contract agreement to be executed is attached herewith as Annexure-C. Bill would be paid only after signing of Contract agreement.
- 9. In case services of Service Provider are not satisfactory on any account, the contract can be terminated by giving 15 days' notice.
- 10. If at any time any question, dispute or difference, what so ever shall arise between the contractor and PSTCL, upon or in relation to, or in connection with the order contract, he may go for arbitration as per Arbitration clause contained in Works Regulations, 1997 as amended from time to time.
- 11. **JURISDICTION:** All legal proceedings against this contract shall be in the jurisdiction of Civil Court at Gurdaspur.

The tenders will be accepted up to 11.00 AM on 29.01.2024 and will be opened on the same day in the presence of contractor/bidder at 11:30 AM on 29.01.2024 who may choose to be present in the office of the Sr Xen/Protection Division, PSTCL, Gurdaspur.
