1. The tender documents shall be issued only to those 1st class working building contractors who have enlisted with PSTCL, PSPCL, erstwhile PSEB, Pb. PWD/ B&R, MES, Railways & have satisfactorily executed similar work of same magnitude during the last two years.
2. The tenderers should enclose Rs.2000/- (Rs. Two Thousand only) in shape of Bank draft for in favour of Addl.S.E./C.W.Divn., PSTCL, S.A.S.Nagar payable at Chandigarh/Mohali towards cost of tender documents/specification non-refundable.
3. Tender of such bidder who do not enclose the demand draft of cost of tender document/specifications shall not be opened.
4. All tenders must be accompanied by earnest money at the rates and in the form prescribed in the tender document accepted in the case of those tenderers who have specially exempted there under.
5. Conditional tenders will not be accepted.
6. Tenderer will have to comply with all the rules and regulations under factory act, Industrial disputes act, E.P.F Act., Labour Laws and Bonus Act & Retrenchment compensation etc.
7. The tender shall be issued to those tenderers who have Vat. No., EPF No. & Service tax No.
8. Tender received telegraphically through telex or Fax/e-mail shall not be accepted.
