Rates of schedule items to be governed w.r.t. Sanctioned Premium are applicable for zone on the date of opening of tender and those of non-schedule items to be governed w.r.t. the rates approved by PSTCL on the basis of analysis of rates.

The bidder shall submit to this request for issue of tender specifications along with experience details, copy of registration with PSTCL/PWD/Irrigation/Public Health/MES or any other public sector or Govt. undertaking, list of available T&P items, copy of memorandum of incorporation of company and its registration with registrar of companies and income tax return filed with income tax department for the last 3 assessment years.

4. Tender documents shall be issued to only those registered class A, B & C (class I, II & III) grade contractors and firms who have adequate experience of carrying out similar type of works.

8. Those bidders who have been issued tender specifications are to submit their complete tender documents on or before the last date mentioned above along with **fixed earnest money of Rs.8,800 for work sr. no. at 1 and Rs. 7,400/- for work at sr. no. 2**

9. Notwithstanding anything state above, the competent authority reserves the right to assess the bidder's capabilities and capacity to execute the contract satisfactorily before deciding on issue of tender documents and even afterwards for deciding about awarding the work.
