1. Tender fee is NIL. All quotations exceeding Rs.50000/- should accompany earnest money @2% of the tender value rounded off to a multiple of Rs10/- on the higher side subject to a minimum of Rs5000/- in shape of demand draft / cash payable at Mandi Gobindgarh in favour of Sr. Xen , P&M Division-2 , PSTCL, Mandi Gobindgarh.
2. The tenderers are required to submit tenders in two separate envelopes. First Containing deposit of Earnest money and the second containing tender quotation. The envelope containing the earnest money shall be opened first and if it is found in order then second envelope containing the tender quotation shall be opened.
3. Quotations shall be opened at 11:30hrs on 20.02.2024 and in case of holiday on that day, the quotation will be opened on the next working day. The Quotation should be complete in all respects: conditional incomplete tenders or telegraphic tenders are liable to be rejected.
