In case all such connected cases are clubbed/consolidated for hearing by the Court, the existing rate of counsel fee for connected cases will be payable. In cases which are not clubbed/consolidated, the cases filed first before the Court shall be treated as lead case which will be paid at the approved rates of fee and the remaining cases on the same subject shall be treated as connected cases for which the revised fee approved as above shall be applicable.

All terms and conditions as laid down in the Office Order No.19 dated 31.05.2011 issued by Dy. Secretary/ Law-cum-Legal Advisor, PSPCL and other clarificatory instructions except the above term issued from time to time shall remain the same".

The revised norms of fee as above shall be applicable to the cases allotted to the Advocates on or after the date of issuance of this order.
