This has been examined and it has been decided that:-

- I. In cases, where the PSTCL employee is registered in the National Pension System, employee's share alongwith return (growth) on his single share shall be refunded to him. **The remaining amount i.e. the PSTCL share and return (growth) thereupon shall be deposited into the PSTCL Account under the relevant receipt head. This amount shall be withdrawn through bank account of AO/Cash, PSTCL, Patiala.**
- II. In cases, where the PSTCL employee is not registered in the National Pension system, the subscription deducted (single share) from the employee's pay and lying with the PSTCL shall be refunded alongwith interest at the rate applicable on EPF during that period upto the end of the month preceding in which the dismissal/removal/termination orders were passed.

Note:- In both the cases above, when a subscriber, has been dismissed/removed/terminated etc. from the PSTCL Service but has appealed

against the orders, the balance at his credit shall not be paid over to him until final orders confirming the decision are passed on his appeal.

Provided that in the cases covered under (II) above:-

a) Where the orders of dismissal/removal/terminated etc. have been confirmed by the appellate authority, interest shall be paid on the balance upto the end of the month preceding that in which such orders on appeal are passed.

b) Where during the pendency of appeal, in case normal superannuation date arrives, the amount at the credit of such subscriber may be paid to him after the dated on which he would have retired on superannuation had he not been dismissed/removed/terminated etc. In this case interest shall be paid on the balance upto the date of superannuation.

Subject:- Release of subscription deducted under New Pension Scheme to dismissed / removed / terminated Government employees.

Sir/Madam,
In Supersession of earlier instructions issued vide circular No.5/6/2014-2FPPC/850894/1 dated 30.09.2016.

2. I am directed to invite your kind attention on the subject cited above and to say that New Pension Scheme has been implemented vide instructions no. 3/72/200 3-3FPPC/7280 dated 12.12.2006, as amended from time to time for the employees joining Government Service on or after 01.01.2004.

3. Recently some cases have come to fore where an employee covered under New Pension Scheme, due to various reasons, is dismissed / removed / terminated from Government Service and questions have arisen as to what payment is to be made to such a dismissed / removed / terminated employees under New Pension Scheme.

4. This has been examined and it has been decided that:-

- I. In cases, where the government employee is registered in the National Pension System, employee's share alongwith return (growth) on his single share shall be refunded to him. The remaining amount i.e. the Government share and return (growth) thereupon shall be deposited into the Government Account under the relevant receipt head i.e. 0071-Pension and other pensionary benefits.
- II. In cases, where the government employee is not registered in the National Pension System, the subscription deducted (single share) from the employee's pay and lying with the Government shall be refunded alongwith interest at the rate applicable on EPF during that period upto the end of the month preceding in which the dismissal/removal/termination orders were passed.

Note:- In both the cases above, when a subscriber has been dismissed / removed / terminated etc. from the Government Service but has appealed against the orders, the balance at his credit shall not be paid over to him until final orders confirming the decision are passed on his appeal.

Provided that in the cases covered under (II) above:-

- (a) Where the orders of dismissal / removal / terminated etc. have been confirmed by the appellate authority, interest shall be paid on the balance upto the end of the month preceding that in which such orders on appeal are passed.
- (b) Where during the pendency of appeal, in case normal superannuation date arrives, the amount at the credit of such subscriber may be paid to him after the date on which he would have retired on superannuation had he not been dismissed / removed / terminated etc. In this case interest shall be paid on the balance upto the date of superannuation.

Sir/Madam,

I am directed to invite your kind attention on the subject cited above and to say that National Pension System is being implemented for the employees who entered Government Service on or after 01.01.2004 vide instructions no. 3/72/2003-3FPPC/7280 dated 12.12.2006 issued by Finance Department in accordance with the policy instructions issued by Government of India.

2. From recent past, some cases have come to the fore where an employee covered under National Pension System (NPS), due to various reasons, is dismissed/removed from the Government service. A question has arisen as to what payment is to be made at the time of dismissal/removal from service under National Pension System. In this regard, it has been decided that in case an employee covered under NPS is dismissed or removed, the Government's share and the interest thereupon shall not be released to such an employee. However, employee's own share towards NPS fund and the interest earned thereupon shall be released.

3. Strict compliance of these instructions may kindly be ensured.
