Power Grid Corporation of India Limited (PGCIL) was incorporated under the Indian Companies Act. 1956 with the mission of "Establishment and Operation of Regional and National Power Grids to facilitate transfer of electric power within and across the regions with reliability, security and economy on sound commercial principles". PGCIL, the Central Transmission Utility (CTU) of the country is a Schedule - "A"/Navratna CPSE with the administrative jurisdiction of Mio Power
