It is therefore requested to provide details of all subdivisions/stores/sub-stores (Division wise) under your control through Head of departments as per format attached (in MS-excel file) by 30/06/2018 at ao-gst@pstcl.org User ID and Password will be provided by this office to prepare/raise e-way bills at your level on the Inter-state and Intra-state movement of Goods exceeding Rs. 50,000/- through the GSTN Portal on the link www.ewaybillgst.gov.in.
