PSTCL requires the following type of clamps/ connectors-

- 1. 220 KV Quad Groove Circuit breaker clamp: Aluminium Alloy Heavy duty Bi-metallic 220 kv Breaker Complete assembly, made out by die casting process & all ferrous parts shall be Hot dip galvanized one side of which is suitable or Flat side of breaker bushing Copper rod & other side suitable for Quad ACSR Zebra Conductor with Bimetallic with minimum current carrying capacity 1600 Ampere strictly as per IS 5561 with latest amendments. (Compatible with Siemens Make Circuit Breaker Type 3APFI)
- 2. 220 KV Quad Groove CT clamp: Aluminium Alloy Heavy duty Bi-metallic 220 kv CT Complete assembly, made out by die casting process & all ferrous parts shall be I dip galvanized, one side Hot dip of which is suitable or Flat side of breaker bushing Copper rod & other side suitable for Quad ACSR Zebra Conductor with Bimetallic with minimum current carrying capacity 1600 Ampere strictly as per IS 5561 with latest amendments.
- 3. 220 KV Quad Groove Post Insulator Clamp: Aluminium Alloy Heavy duty Bi-metallic 220 kv Bus Bar made out by die casting process & all ferrous parts shall be Hot dip galvanized, one side of which is suitable or Flat side of breaker bushing Copper rod & other side suitable for Quad ACSR Zebra Conductor with Bimetallic with minimum current carrying capacity 1600 Ampere strictly as per IS 5561 with latest amendments.

- 3. The undersigned can increase/decrease the quantity of order as per actual site requirements or cancel the tender/quotations at anytime without any notice.
- 4. No subletting of work shall be permitted at any stage.
- 5. Quoted rates shall include everything and nothing extra over & above the quoted rate shall be payable. GST (if applicable) shall be paid as per actual.
