

1. The work is to be completed within 10 days from the date of receipt of detailed order/LOI.
2. Tenders shall be opened in the presence of the tenderers or their authorized representative who wants to be present.
3. The tenderer should quoted rate for all items.
4. The quantity of trees to be sold may vary.
5. Rates of taxes and duties if any applicable must be mentioned clearly otherwise maximum rate shall be taken into account for evaluation purposes.
6. A set of tender documents(non transferable) containing tender specifications, general instructions, terms & conditions can be obtained from the office of Sr. Xen, TLSC Division, PSTCL SAS Nagar upto 10:00 AM on dated 28-08-2023.
7. All tenders must be accompanied by earnest money in shape of PSTCL cash receipt or pay order. Demand draft in favor of Punjab State Transmission Corporation Limited, payable at Patiala in a separate envelope except in the case of those Venders who are specifically exempted for the same.
8. **Earnest money shall be 2% of tender value with minimum of Rs.5000/- whichever is higher.** Earnest money shall be nil for work order below Rs.50,000/- as per Works Regulations The tenders from the firm having permanent earnest money for Transmission works shall also be accepted providing a certificate to this regard is contained in the envelope containing earnest money.
9. The quoted rate should be valid for 120 days from the date of opening of tender.
10. Tenders for part work, Conditional tenders, and telegraphic tender through telex, fax or tenders not on prescribed forms of tenders without earnest money in the required shape shall not be accepted.
11. All the T&P/machinery required to carry out the work is to be arranged by the bidder.
12. In case the date of opening of tenders happens to be a holiday, the tenders will be received and opened on the next working day at the same time.
13. The competent authority reserves the right to increase/decrease the scope of work or also reject any or all the tenders so received without assigning any reason whatsoever.
14. Bidders should note that in case of award of contract they shall themselves be responsible for compliance of various provisions of EPF Act 1952 amended up to date as principal employer, GST which ever are applicable. All obligations arising on this account shall be sole responsibility of the contractor.
15. Tenders received after the due date & time, even if posted before the due date of opening shall not be entertained at all.
