Please refer to this office memo no. 14708/Misc-698 dated 28.11.2016 vide which M/s Lanstec India (Authorized dealer of M/s Matrix Comsec Pvt. Ltd., Vadodra) was requested to make compliance of the provisions of the W.O within 21 days, but firm has failed to make compliance.

Further, this office memo no.13387/Misc-698 dated 28.04.2017 vide which M/s Matrix Comsec Pvt, Ltd., Vadodara, Gujarat was requested to make compliance of the provisions of W.O including amendments placed to M/s Lanstec India, Patiala within 07 days, but again firm (being a principal firm) has failed to make compliance of the provisions of the above said W.O.

In this regard, it has been decided by the competent authority as under:-

1. To suspend the business dealings with the M/s Lanstec India (Authorized dealer of M/s Matrix Comsec Pvt. Ltd, Vadodra) and the principal firm i.e. M/s Matrix Comsec Pvt. Ltd, Vadodra for the period of two years.
2. To forfeit the security deposit (i.e. Rs. 22,000/-) lying with PSTCL of the above said work order-cum-contract agreement.
