Subject: Compliance of directions regarding service of court notices/summons etc. as per the orders dated 26-05-2023 of the Hon'ble High Court of Punjab and Haryana in COCP No. 959 of 2023 in CWP No. 17361 of 2021 - AMAR SINGH V/S SANJEEV KUMAR

All the Administrative Secretaries of the Government of Punjab, may kindly refer to the subject cited above.

- 2. During the proceedings of the COCP No. 959 of 2023, Hon'ble High ourt of Punjab and Haryana vide orders dated 26-05-2023 has issued the below ioned directions regarding the service of summons, notices etc.
 - 1. The service of notices, summons and exchange of pleadings may be effected by e-mail, FAX and commonly used instant messaging services like WhatsApp, Telegram, Signal, etc.
 - 2. While accepting the pleadings, all the Revenue Courts will insist upon the parties, as well as their Advocates representing them to provide their e-mail address. Phone number with WhatsApp including similar information for the respondents, so far available with the litigant.
 - 3. In future, all the notices to the Lawyers may be issued on e-mail or commonly used instant messaging services.
 - 4. Where the party is avoiding the service, the procedure of munadi be done away being an obsolete procedure in the wake of advancement of technology and if the service of the summons is not effect on the very next date, by adopting the aforesaid methods additionally to the discretion of the Revenue Courts, publication be ordered in a newspaper.
 - 5. So far as the filing the appeals/revisions under the Act is concerned, the original record may not be requisitioned by the Appellate/Revisional Court and only the of sent be the record copy/photocopy Appellate/Revisional Court, so that the Court at first instance i.e. the Assistant Collector Ist Grade or the Assistant Collector IInd Grade or the Collector, as the case may be, may continue with the proceedings unless there is a stay by the Appellate/Revisional Court

You may also download the copy of order dated 26-05-2023 in COCP No. 959 of 2023 from the official website of the Hon'ble High Court of Punjab and Haryana at Chandigarh for ready reference.

3. Besides the above said orders, it is also intimated that there has been an amendment in The Punjab Land Revenue Act, 1887 in Section 20 Mode of Service of Summons Para (2) substituted vide Punjab Act No.21 of 2020 w.e.f.

10/12/2020.

4. Therefore in the above context, I have been directed to request you to issue necessary guidelines to all the concerned in your Department to comply with the orders of the Hon'ble High Court and also provisions of 'The Punjab Land Revenue Act, 1887' in matters pertaining to Service of Summons/Notices particularly in Revenue Courts.
