Quarterly and Annualy VAT/CST returns (Form VAT-15, VAT-18, VAT-19, VAT-20, VAT-23, VAT-24), tax assesment and on line issuance of 'C' forms etc. It will also include consultation on VAT/CST matters, responding to the notice received from the concreded department, if any. Terms and conditions are as under:

1. The rates should be firm and inclusive of all taxes/levies except service tax which will be borne by the PSTCL.
2. The firm shall be responsible to complete the work as per schedule & instructions given under Punjab VAT Act-2005 and as per directions of Punjab Excise and Taxation Department.
3. Firm will have to submit revised returns or any other requisite information on the format/Form as and when demanded by the Punjab Excise and Taxation department without any additional charges.
4. The payment against the work order will be made on completion of work at the end of each half year in two half yearly instalments through cheque on submission of bill (in triplicate) to under-signed.
5. Any other conditions as contained in Works Regulations of PSPCL/PSTCL as amended from time to time will be applicable.
