Subject: Regarding termination of services on account of submission of forged certificates for getting appointment in PSTCL -NGE Mr.Paramjit Singh S/o Sh.Amarjit Singh, SSA, Emp.ID 603197.

Mr.Paramjit Singh S/o Sh.Amarjit Singh r/o H.No.593, St.No.02, Farid Nagar, near Nankiana Chowk, Sangrur was appointed as SSA under CRA-02/PSTCL/2012 vide this office letter No. 601 dated 19.7.2013. He joined PSTCL on 19.08.2013 as SSA and at present he is working under the control of Addl.SE, 400 KV S/S Dhuri under P&M Circle, PSTCL, Patiala.

For getting appointment as SSA, Sh.Paramjit Singh submitted all the requisite documents/certificates including degree as well as detail marks certificates of BE(Elect.). He was issued offer of appointment subject to the condition that certificates produced by him shall be got verified from the concerned Board/University. In the event his certificates are not found as genuine, his services are liable to be terminated.

Dy.Registrar (Academics), Thapar University, Patiala vide letter No. Ref.No. AS/2559/1954 dated 11.12.2014 has intimated that the degree of BE(Elect.) had never been issued by them to Sh.Paramjit Singh, Reg.No.BE-99/90. It has also been remarked that **'The degree certificate bears forged signature of the issuing authorities.'**

Subsequently photocopies of all the certificates viz. detail marks certificates of BE(Elect.) and degree certificate (photocopied both sides) bearing Regn.No. BE-99/90, as submitted by Mr.Paramjit Singh S/o Sh.Amarjit Singh, were forwarded to the Dy.Registrar (Academics), Thapar University, Patiala vide this office letter No.19326 dated 19.12.2014(**Flag-'C'**) to re-check and report for the purpose of verification and genuineness of the certificates.*All the original certificates were also shown to the issuing authorities personally through a representative of this office.

Registrar (Academics), Thapar University, Patiala vide their letter no. AS/2559/1995 dated 22.12.2014 again confirmed that Sh.Paramjit Singh has not passed the Bachelor of Engineering Degree from their University. They have informed that he was admitted to BE/Elect. Engg. in July 1990 but he left the University in 1996 without completing the degree and all the certificates viz. degree as well as detailed marks certificates of BE/Elect., had never been issued by Thapar University(Formerly Thapar Institute of Engineering and Technology, Patiala).

He was issued a notice vide this office memo no.19452 dated 24.12.2014 to explain his position in writing in this regard upto 5.00 p.m. of 31.12.2014. But the concerned employee has not given anything in writing to this office till 12-01-2015.

As the reports received from the certificates issuing authority viz. Thapar University (Formerly Thapar Institute of Engineering and Technology, Patiala) are sufficient to show that the concerned employee had submitted forged certificates of BE(Elect.) for getting employment in PSTCL as SSA. And also no reply in his own favour has been submitted by Sh.Paramjit Singh in response to the notice served upon him. Thus being a prima facie case of forgery, fraud and cheating. Hence, services of Sh.Paramjit Singh, SSA, Emp.ID-603197 are hereby terminated with immediate effect i.e. from the date of issue of this office order.

This termination of service shall be a disqualification for future employment under any Govt./Semi-Govt. department, Board or Corporation.

This issues with the approval of competent authority.
