The provision to accept tender document fee, processing fee, and EMD through online payment mode is already available on GePNIC portal since the inception of the portal (i.e. January-2018).

The Punjab State Transmission Corporation Limited (PSTCL) has started using this portal since October-2018 with offline payment mode and are in continuation with same option so far. The PSTCL was allowed to use offline payment mode for a few days of the beginning on the request received from your end.

The incessant use of this feature is inappropriate and should be stopped immediately. If anything fallacious happens in future then only PSTCL shall be responsible for that.

Kindly request the concerned authorities to park EMD, tender document fee through centralized bank account by prospective bidders instead it is directly taken into your own bank accounts.

Please treat it urgent and important.
