4. The interested contractors / Firms must submit their request for issue of Tender Specifications by 04/01/24 till 03.00 PM (cost of tender specification is Nil)
5. The tender specification shall be issued to eligible bidders by 04/01/24. The detail of receipt & opening of tenders in this office are as given below:-

Tender of the contractors who do not purchase the tender documents in advance shall not be received.
6. Requests for issue of tender documents received late due to any reason including postal delays or request not carrying information / documents asked vide Para 3 or request received through telex, fax, telegraphically shall be rejected. Conditional requests are also liable to be rejected.
7. Rates quoted in tender should be valid for 120 days.

Those bidders who are issued tender, specification are to submit their complete tender documents on or before the last date mentioned above along with fixed earnest money Rs (As per tender documents) . For more details on earnest money, tender documents may be referred. Not with standing anything stated above, the competent authority reserved the right to assess the bidder's capabilities and capacity to execute the contract satisfactorily before deciding on issue of tender documents and even afterwards for deciding about awarding the work.


