Sanctioned premium as applicable for zone on the date of opening of tender and those of non-schedule items to be governed w.r.t. the rates approved by P.S.T.C.L. on the basis of Analysis of Rates.

The bidder shall submit to this office request for issue of tender specification along with experience details, copy of registration with PSTCL/PWD/ Irrigation /Public health/MES or any other public sector or Govt. undertaking, list of available T & P items, copy of memorandum of incorporation of company and its registration with registrar of companies and income tax return filed with income tax department for last 3 assessments years.
4. The interested contractors / Firms must submit their request for issue of Tender Specifications by 30/10/23 till 02.00 PM (cost of tender specification is Nil)
5. The tender specification shall be issued to eligible bidders by 21/07/23 The detail of receipt & opening of tenders in this office are as given below:-

Opening of Tenders: 31/10/23 at 11:30 A.M.
Tender of the contractors who do not purchase the tender documents in advance shall not be received.
6. Requests for issue of tender documents received late due to any reason including postal delays or request not carrying information / documents asked vide Para 3 or request received through telex, fax, telegraphically shall be rejected. Conditional requests are also liable to be rejected.
7. Rates quoted in tender should be valid for 120 days.

Those bidders who are issued tender, specification are to submit their complete tender documents on or before the last date mentioned above along with fixed earnest money Rs (As per tender documents) . For more details on earnest money, tender documents may be referred. Not with standing anything stated above, the competent authority reserved the right to assess the bidder's capabilities and capacity to execute the contract satisfactorily before deciding on issue of tender documents and even afterwards for deciding about awarding the work.

In case last date of receipt of request for issue of tender document, receipt and opening of completed tenders, happens to be a holiday, the receipt and opening will be carried out by/on the next working day up to/at the same time.
