(A) General Conditions for Outsource Vehicle:

(B-1) Terms and Conditions for Vehicles:

- 1. The vehicle will be used as conveyance by PSTCL and will be stationed at 400 KV Sub Station Sri Muktsar Sahib for journey/travel usually in the State of Punjab, H.P., J & K, New Delhi, NCR and UT of Chandigarh or beyond that as per requirement.
- 2. The necessary all India permit, in this regard, will be arranged by the Contractor. The toll Tax/Toll Barrier if applicable at any route, will be paid by the PSTCL on production of actual receipts.
- 3. The cost of consumables, in addition to Diesel, like Mobile Oil, Lubricants, etc. will be borne by the contractor.
- 4. The vehicle shall be duly ensured comprehensively including third party insurance during the period of engagement with the department. Insurance premium shall be paid by the contractor lodging insurance claims with the insurance company will be the contractor's responsibility in case of any such eventuality.
- 5. In case of accident, any type of challan, halt charges, penalty, damages, court case, police case etc. the sole responsibility will be of the Contractor of the vehicle and Punjab State Transmission Corporation Ltd. will be not be party in such case.
- 6. The contractor can send the vehicle for minor repairs, if needed, once in a month for one day preferably on holidays without any deduction. - 2. The Contractor shall also make available the Registration Certificate of the vehicle in his name with the driver of the vehicle along with all other relevant documents for insurance, Road Tax etc. necessary to keep the vehicle running on the road at all time during the contract period.
- 3. The Driver shall maintain a Log-book & the log-book will be signed by the PSTCL's authorized official using the vehicle on the completion of the journey. However Log-book will be verified from time to time by the Sr.XEN.
