DETAILED NOTICE INVITING TENDER

- On line Tenders in the prescribed form as uploaded on website are hereby invited from the enlisted contactors for the work of (i) Stub strengthening of concrete stubs,repair and raising of offchutes of 132/220kv lines under P&M Circle Jalandhar,P&M Circle Amritsar And P&M Circle Ludhlana.from the website www.eproc.punjab.gov_EMD shall be deposited online.
- 2. Only e-tendering mode will be acceptable. The e-tender should be submitted through online mode on the website (https://eproc.punjab.gov.in/nlcgep/app)" or www.eproc.punjab.gov)
- 3. Eligibility Criteria:

To qualify for getting himself registered with www.eproc.punjab.gov, each bidder in its name should have achieved following mile stones:

- (i) Average Annual financial turnover during the last 3 years, ending 31st March of the previous financial year, should be at least 30% of the estimated cost.
- (ii) Experience of having successfully completed similar works during the last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:
 - (a) Three similar completed works costing not less than the amount equal to 40% of the estimated cost. Or
 - (b) Two similar completed works costing not less than the amount equal to 50% of the estimated cost. Or
 - (c) One similar completed work costing not less than the amount equal to 80% of the estimated cost.
- (iii) Similar work means Repair of stubs,offchutes,raising of muffs;Construction of 132KV/220KV/400KV transmission lines.
- 4. The time allowed for completion of work will be **2 Months** after the date of issue of letter of intent or Allotment Letter to the firm whichever is earlier.
- 5. a.)Earnest Money:

The tenderers shall be required to submit 2% of tendered amount (Minimum Rs. 84,000/- for Earnest Money through online mode.

b.)PROCESSING FEE:

The bidders have to pay the processing fee as per the directions issued by Directorate of Governance reforms and Public grievances (Govt. of Punjab). For details refer to the relevant douments attached in Other documents.

- 6. Five percent security will be deducted from the running bills of the contractor.
- 7. The rates shall be valid for a period of 120 days from the date of opening of the Tender. The earnest money shall be forfeited if the tenderer withdraws or modifies his offer within the validity period or fails to sign the (Formal Contract) agreement after acceptance of his offer or fails to commence the work within ten days of issue of acceptance letter. The earnest money will be forfeited.
- 8. On acceptance of the tender, the firm shall arrange the availability of an accredited representative, fully authorized in writing at the site of work to receive instructions of the

compliance prompt ensure Engineer-in-charge and representative his thereof.

- 9. The Competent Authority does not bind itself to accept the lowest rate or any tender and tenderer shall reserve to the tender and tenderer shall be to accept the tender and tenderer shall be to accept the tender. reserves to itself, the right of accepting the whole or part of the tender and tenderer shall be bound to perform the same at the quoted rates.

Before filling the tender, the site shall be visited by the representative of the firm and satisfy itself as to the conditions prevalent there especially regarding accessibility to the site, naturally installation of Tools and extent of the ground, working conditions, stacking of materials, installation of Tools and Plants at Plants etc. accommodation and movement of labour, supply of water and power for satisfactory completion of the works contract. - 11. The tenderer shall bear all costs associated with the preparation and submission of his tender and the department shall in no case be liable for these costs.
- 12. GST applicable as per Govt. Norms and shall be paid extra by PSTCL.
- 13. Each tenderer shall submit only one tender, either by himself or as partner in a joint venture A tenderer who submits or participates in more than one tender, will be disqualified.
- 14. Unless otherwise stated the contract shall be for the whole work as described in the "Schedule of items of works". The contractor shall be bound to complete the whole work as described in the schedule of items of works including the additional items if any, as per instructions. The certificate of completion as issued by the Engineer-in-Charge shall be the conclusive proof of completion of work.
- 15. The tenderer has to fill the tender form as given by the department. The scanned copy of the following documents shall accompany the tenders. If required by the department they can ask for the original copy for verification from the tenderer.
 - Registration Certificate of the firm or company
 - Allotted EPF Code Number from Employees Provident Fund Commissioner and latest (ii) copy of challan of Deposit of EPF of the employees. Or L&C Societies with employee strength of less than 20 employees are exempted from EPF scheme.
