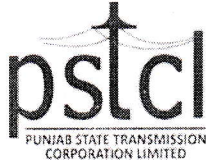

Sub:- Contempt Petition pending before this Hon'ble Court (Punjab & Haryana High Court).

Addl. Advocate, General wrote a D. O. No. 3412 dt. 22/25/February, 2019 to Chief Secretary, Govt. of Punjab which is received in this office from CMD, PSTCL. It has brought to the kind notice of higher authorities that Hon'ble Contempt Court has taken a very serious view regarding the non-compliance of orders passed in the writ petition. The Hon'ble Contempt Court observed that if the order is non-complied with by the first date, a cost of Rs. 5,000/- would be imposed which is to be paid to the petitioner/petitioners by way of demand draft. Further if next opportunity would be granted for compliance of the order, in that case, the salary of official concerned/responsible for non-compliance would be stopped (copy enclosed).

You are therefore requested to issue directions to all the offices under your control to prepare a list of contempt petitions pending before Punjab & Haryana High Court & comply with the order passed in the writ petitions at the earliest, failing which the concerned office would be facing adverse order from the Hon'ble Court.
