Subject: - Regarding concessions offered by the Phull Neuro & Multispeciality Hospital Patiala to PSTCL employees/ pensioners/ family pensioners and their dependents.

The Phull Neuro & Multispeciality Hospital, Adjoining Maharaja Yadwindra Enclave, Near PRTC workshop, Nabha Road, Patiala has agreed to provide the following concessions to the PSTCL employees/pensioners/family pensioners and their dependents:


1. OPD:
a) 50 % discount on all OPD Consultations. b) 15 % discount on OPD Medicine. c) 20 % discount on all Dental Procedures.
2. IPD :
a) 15% discount on Room Rent. b) 15% discount on Doctor visit. c) 15% discount on IPD Medicine. d) 10% discount on IPD diagnostic.
3. Laboratory & Diagnostics:
a) 20% discount on Lab Test except outsourced. b) 20% discount on Neurological Test (EEG, EMG, BERA, Video EEG, RNST, VEP, NCV 2 limbs, NCV 4 limbs.) c) 10% discount on CT, X-ray.
4. Ambulance Service:- In case of emergency free Ambulance Service will be provided to PSTCL employees in Patiala City.

The discount/concessions given by the hospital are subject to the following conditions:-

- i. PSTCL will sign no agreement with the hospital in this regard.
- ii. PSTCL will only circulate the offer of concessions given by the hospital and will not give any clarification or attend any complaint in this regard.
- iii. PSTCL will not bind any employee/pensioner/family pensioner and their dependents to get the treatment from their Hospital.
- iv. Payment of OPD and IPD will be made directly to the hospital by the employee / pensioner/ family pensioner and their dependents. However the employee / pensioner/ family pensioner, if entitled to get reimbursement, can claim re-imburement from PSTCL as per prevailing instructions and at the rates/amount verified by the Health department wherever applicable.

- v. PSTCL will not give any surety regarding payment by its employees/ pensioners and their dependents to the hospital.
- vi. The beneficiaries must produce the PSTCL Identity Card at the time of taking any service at OPD/IPD.
