In reference to above subject, the following amendment is hereby made in the PSEB Purchase Regulations, 1981 (Reprint-2005) which is presently being followed by PSTCL:-

For this purpose the merit position of the Punjab firms shall be prepared separately, However, where the Punjab firms qualify amongst the lowest bidders on their own quoted rates, they shall form part of the original quoted list for the purpose of placing orders.
