Subject: **Important Instructions i.r.o e-Procurements through GePNIC portal: Regarding shifting from "Department Model" to "Bidder Model" with effect from 01.09.2022.**

Department of Governance Reforms and Public Grievances (DGR), Punjab who is maintaining the GePNIC portal has informed that **for all the on-boarded organizations on GePNIC portal, Departmental Model is being changed to Bidder Model with effect from 01.09.2022.** in respect of charging processing fees, etc. for tender hosting, for details please refer to the enclosed copy of the DGR, Punjab bearing No. PSeGS-EPROOPNIC/1/2017-DGR-3822 dated 22.07.2022 addressed to this office.

In short under this model, the bidder(s) have to pay the processing fee amount directly to the implementing agency instead of by PSTCL, rates of which at present are mentioned in the table below (please refer to the above referred letter):

Tender Value	Processing Fee Amount (there is no tax component in it)
0	₹ 2,360/-
₹ 1/- to ₹ 500,000/-	₹ 5,90/-
₹ 5,00,001/- to ₹ 50,00,000	0.118% of Tender Value
₹ 50,00,001/- to above	₹ 5,900/-

Higher ups have desired that all the concerned offices in PSTCL be informed regarding this shifting from Department Model to Bidder Model, and each office may in inform all their prospective bidders/ vendors in advance regarding processing fee chargeable by GePNIC portal as well as in the each NIT itself.

Subject: - To Shift PSTCL from "Department Model" to "Bidder Model".

The Processing Fee, for published tenders on GePNIC portal (<https://eproc.punjab.gov.in>), is being collected by the implementing agency i.e. DGR via two models i.e. Department Model and Bidder Model.

**Processing Fee for Department Model**

In this model, the department itself has to pay the processing fee amount i.e. ₹ 8,260/- (there is no tax component in it), per tender irrespective of no. of participants in a tender, to the implementing agency i.e. DGR.

**Processing Fee for Bidder Model**

In this model, the bidder(s) have to pay the processing fee amount (per bidder per tender) directly to the implementing agency as per table given below:

Tender Value	Processing Fee Amount (there is no tax component in it)
0	₹ 2,360/-
₹ 1/- to ₹ 5,00,000/-	₹ 5,90/-
₹ 5,00,001/- to ₹ 50,00,000/-	0.118% of Tender Value
₹ 50,00,001/- to above	₹ 5,900/-

The PSTCL is using GePNIC portal, for the publication of online tenders, from 11.09.2018 and availing the feature of Department Model to pay the "Processing Fee" charges to the implementing agency since then.

It is to inform you that the competent authority has ordered to shift from Department Model to Bidder Model for all the on-boarded organizations on GePNIC portal from 01.09.2022.
