
General Terms & conditions

1. The rates should have detail of all the taxes and should as per PSTCL Corporate Horticulture Policy
2. Conditional tenders will not be entertained.
3. Undersigned reserve the right to cancel the above enquiry without any intimation.
4. Contractor is required to be submitted the earnest money as per the rules and regulation of PSTCL.If the amount of work increases Rs 50,000/-then 2% Earnest money should be deposited with minimum of Rs 5000/-
5. The quotations should accompany with PAN proof, centralized registration number of GST.
6. The payment shall be made electronically through centralized payment system of PSTCL, Patiala.
7. Qty. of material/work can be increased or decreased.
8. In case of any dispute jurisdiction within Pathankot Dist.
9. Earnest money tender/fee and other relevant documents shall be received in the office of Addl.SE P&M division PSTCL, Sarna on or before the due date/time given in the tender notice and shall be opened in the presence of tenders or their authorized representatives who may like to be present. In case the due date of opening of tenders happens to be holiday documents such as tender fee earnest money etc relating to tender shall be received and opened at the same time on the next working day.

MISCELLANEOUS TERM & CONDITIONS

- 1 All the machinery/equipment/flexible water pipes will be arranged and maintained by the contractor from his own source.
- 2 The garden waste will be disposed off by the contractor at the specified place with his own machinery and manpower.
- 3 Contractor will not further sublet the work.
- 4 All the plants material i.e. Grass trees, shrubs, seasonal seedlings and fertilizers (organic, inorganic) will be supplied by the department However, in case of causality of plant material above 5% the cost involved will be recovered from the contractor bills. All plants/shady trees will be procured/arranged from the Govt. Nursery/Forest Deptt. of PB Govt.
- 5 The spray of insecticides /pesticides whenever required will be done by the contractor with the own equipment whereas the same will be supplied by the department.
- 6 Payment of the contractor will be made monthly of the work done as per specified norms of particular month as certified by the incharge of building Substation.
- 7 The cost of water/electricity bills will be paid by the department.
- 8 The contractor is to do only plantation/maintenance as per contract, where as the cost of the major repair such as failure of tubewell bore/breakage of G.I. water pipes/ foot plants/ garden structure with windstorms and soil erosion and the expenditure thus involved will be borne by the department.
- 9 The failure to do the specified work in a particular month or done below specification can lead to cancellation of the contract.
- 10 The contractor shall be required to do the horticulture work anywhere in the Sub-Station office as per instructions of office incharge.
- 11 The contractor shall be fully responsible for any loss/damage to the property or any equipment, personnel or his own staff, caused due to any act of the workmen supplied by him.
- 12 The contractor shall not claim any compensation for any damage or loss resulting to him due to any act of God, riots floods, earthquake etc during the contract period.
- 13 Contract to the service provider may be given for minimum 2 years and can be extended by only one more year.


