A clarification for grant of promotional benefit under note given below Regulation-11 of PSEB (Revised Pay) Regulations, 2009 was issued vide FC No 32/2010 dated 10.08.2010 but some field offices have sought clarifications for giving the right of option in such cases. After considering the matter it is further clarified that in such cases under Regulation-11, the option may be exercised within a period of one month from the date of promotion. In such cases of employees, who stand promoted during the period from the 1st day of January, 2006 to the date of issue of this clarification, the option may be exercised within a period of three months from the date of issue of this clarification.

Other terms and conditions as issued vide O/O No.478/Fin/PRC-302/2006 dated 15.10.2009 (F.C.No.15/2009) will remain the same.
