DETAILED NOTICE INVITING TENDER

1. On line Tenders in the prescribed form as uploaded on website are hereby invited from the enlisted contactors for the work of i) Protection and construction of retaining wall for tower no 71 and 82 of 220 kv line Bhalwan-Dhuri ii) Repair of terracing, water proofing, electrical fittings, washrooms and painting of 220 kv s/s Abohar.
2. The tender documents can be down loaded from the website www.eproc.punjab.gov. EMD shall be deposited online.
3. Only e-tendering mode will be acceptable. The e-tender should be submitted through online mode on the website (<https://eproc.punjab.gov.in/nicgep/app>) or www.eproc.punjab.gov

4. Eligibility Criteria :

To qualify for getting himself registered with www.eproc.punjab.gov, each bidder in its name should have achieved following mile stones: **For Tender enquiry no 84/2023-24**

- (i) Experience of having successfully completed similar works during last 7 years ending last day of month previous to the month in which tenders are invited should be either of the following:
 - a. Three similar completed works costing not less than the amount equal to Rs 3.74 lacs,
 - b. Two similar completed works costing not less than the amount equal to Rs 4.68 lacs.
 - c. One similar completed works costing not less than the amount equal to Rs 7.48 lacs.Similar works means Construction of Brick retaining wall and brick boundary wall.

To qualify for getting himself registered with www.eproc.punjab.gov, each bidder in its name should have achieved following mile stones: **For Tender enquiry no 85/2023-24**

- (ii) Experience of having successfully completed similar works during last 7 years ending last day of month previous to the month in which tenders are invited should be either of the following:
 - a. Three similar completed works costing not less than the amount equal to Rs 3.89 lacs.
 - b. Two similar completed works costing not less than the amount equal to Rs 4.87 lacs.
 - c. One similar completed works costing not less than the amount equal to Rs 7.78 lacs.Similar works means Repair of building work

The time allowed for completion of work for Tender Enquiry No 84/2023-24 will be Four Months after the date of issue of letter of intent or Allotment Letter to the firm whichever is earlier, and for Tender Enquiry No 85/2023-24 will be three Months from the date of issue of letter of intent or Allotment order to the firm whichever is earlier.

5. **Earnest Money:**

- The tenderers shall be required to submit 2% of tendered amount (Minimum Rs. 20000/- for ET-84/23-24 and 85/2023-24, Earnest Money through online
6. The tenderer's EMD deposit (whose tender is accepted) will be converted into security and five percent security will be deducted from the running bills.
 7. The rates shall be valid for a period of 120 days from the date of opening of the Tender. The earnest money shall be forfeited if the tenderer withdraws or modifies his offer within the validity period or fails to sign the (Formal Contract) agreement after acceptance of his offer or fails to commence the work within ten days of issue of acceptance letter. The earnest money will be forfeited.

8. On acceptance of the tender, the firm shall arrange the availability of an accredited representative, fully authorized in writing at the site of work to receive instructions of the Engineer-in-charge or his representative and to ensure prompt compliance thereof.
9. The Competent Authority does not bind itself to accept the lowest rate or any tender and reserves to itself, the right of accepting the whole or part of the tender and tenderer shall be bound to perform the same at the quoted rates.
10. Before filling the tender, the site shall be visited by the representative of the firm and satisfy itself as to the conditions prevalent there especially regarding accessibility to the site, nature and extent of the ground, working conditions, stacking of materials, installation of Tools and Plants etc. accommodation and movement of labour, supply of water and power for satisfactory completion of the works contract. No Claim, what so ever, on such account shall be entertained by the department in any circumstances.
11. The tenderer shall bear all costs associated with the preparation and submission of his tender and the department shall in no case be liable for these costs
12. GST applicable as per Govt. Norms.
13. Each tenderer shall submit only one tender, either by himself or as partner in a joint venture. A tenderer who submits or participates in more than one tender, will be disqualified.
14. Unless otherwise stated the contract shall be for the whole work as described in the "Schedule of items of works". The contractor shall be bound to complete the whole work as described in the schedule of items of works including the additional items if any, as per instructions. The certificate of completion as issued by the Engineer-in-Charge shall be the conclusive proof of completion of work.
15. The tenderer has to fill the tender form as given by the department. The scanned copy of the following documents shall accompany the tenders. If required by the department they can ask for the original copy for verification from the tenderer.

The bid capacity of the prospective bidders will be calculated as under:

Assesses Available Bid Capacity= $(A*N*2-B)$

Where

A= Maximum value of civil engineering works executed in any one year during the last five years taking into account the completed as well as works in progress.

B= Value of existing commitments and on-going works to be completed during the period of completion of the projects for which these bids are being invited.

N=The time period which varies from work to work, however most of works of WRD do fall in category $N=0.5$ (Value considered as per SBD for world bank projects)

The general formula is as detailed below:-

If, completion period <6 months, $N=0.5$ Therefore,

Bid capacity= $A*0.5*2-B=A-B$

If, completion period <12 months, $N=1$ Therefore,

Bid capacity= $A*1*2-B=A-B$

If, completion period <18 months, $N=1.5$ Therefore,


Bid capacity= $A*1.5*2-B=A-B$

If, completion period <24 months, $N=2.0$ Therefore,

Bid capacity= $A*2*2-B=A-B$

And similar exercise be done as the case may be
