
6. Work shall be carried out as per PWD specifications to meet with the requirements of the work at site to the entire satisfaction of the Engineer-in-Charge.
7. GST is applicable as per Govt. norms.
8. The quoted Rate shall be valid up to 120 days and shall remain firm through to the completion of work.
9. If the work is not completed within stipulated period, PSTCL shall impose 0.5% penalty per week subject to the maximum of 5% of the Total amount.
10. Security Deposit: 5% of the Gross Value of the work done will be deducted from the running bills as Security Deposit. No interest shall be payable to contractors on the amount of security deposit.
11. Income Tax, Labour cess shall be deducted at the source as per prevailing rules and rates.
12. All statutory rules and regulations such as EPF regulations, Labour Rules and Regulations, wages regulations etc. shall be followed by the contractor.
