It is informed that this office has put up the matter pertaining to the Charge-Sheet No. 91/ ਕੋਡ ਨੰ. 104162 dated 04.06.2020 (under common proceedings); issued against Er. Nand Lal [Addl.SE/ ਸਿਵਲ ਨਿਰਮਾਣ ਮੰਡਲ, PSTCL, Jalandhar (Voluntarily Retired), Code No. 104162] before the higher authorities for their consideration, and accordingly worthy CMD, PSTCL has imparted the following directions:-

"..... It has also been observed that Chief Engineer/ TS, PSTCL has initiated the disciplinary proceedings after almost one and half year of the decision of the court which is a very long period. In future, all offices may be instructed to initiate the disciplinary proceedings within a period of two months from the cause of an event."

In view of the above, it is requested that in future it must be ensured by yourself that your office and all other offices under your jurisdiction shall initiate the disciplinary proceedings within a period of two months from the cause of an event.
