Sealed tenders are invited in duplicate for the hiring of one No. "Tata Innova/Xylo/Tavera/Tata Sumo(Diesel)and equivalent vehicle, having model not earlier than year 2012 with All India Taxi Registration/Northern India Taxi Registration for PSTCL Amritsar on Monthly basis. a) Monthly fixed charges

b) Per Kilometer running charges
